## 2. The role

### Role

Provide scientific advice to the organisation on a specific topic under any one of the four corporate strategy themes, producing products to address evidence gaps, with emphasis on business priorities. Maintain good customer relationships and use networks to identify solutions to problems and promote Evidence Directorate products to support environmental outcomes.

### Principal accountabilities

1. Produce and present products that meet the needs of the customer, relating to [a specific discipline(s) within any of the four Corporate Strategy themes], in order to generate income and /or support environmental outcomes.
2. Ensure the Environment Agency's interests are accurately and effectively presented by helping to produce high quality evidence outputs
3. Identify, gather and interpret relevant up to date scientific information from internal and external sources to address evidence gaps relating to [a specific discipline(s) within any of the four Corporate Strategy themes], in order to produce high quality evidence outputs
4. Influence key stakeholders and help to build strong partnerships internally and externally; enhancing the reputation of the Evidence Directorate by responding to and resolving issues raised.
5. Assist colleagues across the Evidence Directorate to meet the delivery priorities relating to [a specific discipline(s) within any of the four Corporate Strategy themes].
6. Monitor progress of work, take action to identify gaps in the delivery of priorities to ensure appropriate reallocation of time, finances and effort and enhancement of the service.
7. Provide specialist guidance relating to [a specific discipline(s) within any of the four Corporate Strategy themes] so that others may use our evidence for their day to day business.
8. Keep up to date with the current scientific thinking externally and internally relating to [a specific discipline(s) within any of the four Corporate Strategy themes] and use this knowledge to inform internal priorities.

9. Act as an account manager and provide the link and develop working relationships between the Evidence Directorate and key internal or external contacts in order to integrate and effective environmental outcomes.

This role is office-based and can be located in either Wallingford or Rotherham. The successful applicant will be required to travel regularly for meetings across the UK, and will also be required to travel abroad.

They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.



## 5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting '**Apply**' at the bottom of the advert. (For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.) Once you've clicked this link you'll then be asked 'Do you have the right to live and work in the UK?', 'Do you have the required qualifications or equivalent experience, which were stated in the job advert?' and 'Are you currently an employee of this organisation?' Simply answer yes or no and you can carry on with your application. You'll then see the '**Register**' page. Simply complete the details and select '**Submit Registration**' and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 60 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

### Competence Questions/Statement

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us! You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250 word limit per competence including spaces. It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.

## Application questions

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

## Equality and Diversity

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

## Submitting your application

Once you've filled out and completed everything, you'll be prompted to submit your application. Simply click the button and you're done.
