# 2. The role

### Role

Lead a work group and provide an emergency response service for the Environment Agency on an operational site and ensure work is delivered in a safe and environmentally sensitive way.

### **Principal accountabilities**

Provide effective leadership on health and safety matters by actively promoting health and safety awareness and ensuring the provision and use of safe working practices to ensure compliance with Environment Agency policy and standards

Ensure work on site fully complies with the Environment Agency's conservation and environmental policies and procedures to minimise the risk of environmental damage

Lead an effective delivery of an emergency response capability for floods and environmental incidents to minimise the impact of the incident as directed.

Allocate tasks to the work group so that the site is safe and works effectively.

Communicate with landowners/occupiers and the public to ensure full awareness of the work to be undertaken.

Plan and carry out allocated operational tasks (normally one week at a time) to their work group to deliver the work

Organise and arrange for all equipment/materials to be available on site as specified so that work can be completed in line with required standards and to time scales.

Assist the Team Leader in identifying development needs for team members and to ensure that each team member has capabilities for the task they have been assigned to.

Personal responsibility for own development needs and participate fully in the personal development plan.

### Skills/Abilities/Experience

- You should demonstrate a positive adaptable approach and a 'can do' attitude as a worthy team player.

- Good organisational skills and a proven ability to work under pressure during incidents are essential.

- You must understand site health and safety requirements.
- You'll need good communication skills to work with customers and partners.
- You will also need to coach and encourage others on site.
- We would like you to have a good level of environmental awareness.
- Experience with tablet style computers and familiarity with mobile technology will be useful.
- The ideal candidate will have leadership experience.
- A foundation of practical skills like concreting and minor construction work.
- Experience in Carpentry and in the use of plant and machinery would also be an advantage.

# 3. Salary and benefits

Hours of work:	37 hours FTE, Permanent
Leave entitlement:	Your leave allowance in this role will be minimum 25 days plus bank holidays.
	We also offer up to two days paid environmental outcome days each year. These give you the opportunity to take part in community activities with a clear environmental outcome for people and wildlife.
Pension:	We will enrol you into the Environment Agency Pension Fund (EAPF) on commencing employment, if your employment contract is for 3 months or more. The EAPF is part of the Local Government Pension Scheme (LGPS). It is a career average scheme, which means you will build up benefits based on your pay each scheme year rather than your final salary.
	We will base your pension contributions on your actual pay and you will receive tax and national insurance relief on your contributions. The pension contribution rates currently range between 5.5% to 12.5%. Whilst you are in the scheme we will also pay an employer contribution into your pension pot. We currently pay 18.5%, so this is a very generous scheme.
Work/life balance:	We support flexible working hours and practices to help you strike a good balance between your work life and your personal life. We will also encourage you to keep developing your skills and professional knowledge throughout your career.
Diversity:	We are committed to diversity and inclusion. We want all our staff to feel valued and respected and to see this as a great place to work. Diversity: it's in our nature.
Relocation:	If you need to relocate to take up this role, we might be able to offer financial help with this. This will depend on your circumstances, so if it's something you are interested in, please discuss it with us to find out what the options are.

A full UK driving licence is essential.

Some standby and on-call work will be required. You'll also be required to take part in incident response. Your line manager will confirm the specific arrangements with you depending on your role.

We are fully committed to having an inclusive workforce to reflect the communities we serve. We welcome applications from candidates seeking flexible working patterns, including job share. Please highlight any information regarding preferred flexible working arrangements on your application.

Please note that Environment Agency employees are not civil servants so you may wish to check your eligibility for continuity of employment by contacting your HR department. All eligible bodies are listed in the Redundancy Payments (Continuity of Employment in Local Government etc.) (Modification) Order 1999.

Employment agency workers and contractors are considered to be external candidates and should therefore only apply for positions that are being advertised externally. They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

Please note all successful applicants must undergo Baseline Personnel Security Standard (BPSS) checks prior to commencement of employment. This includes a basic criminal records check.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.

# 5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting **'Apply'** at the bottom of the advert. (For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.) Once you've clicked this link you'll then be asked 'Do you have the right to live and work in the UK?', 'Do you have the required qualifications or equivalent experience, which were stated in the job advert?' and 'Are you currently an employee of this organisation?' Simply answer yes or no and you can carry on with your application. You'll then see the **'Register'** page. Simply complete the details and select **'Submit Registration'** and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 20 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

### **Competence Questions/Statement**

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us! You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250 word limit per competence including spaces. It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.

### **Application questions**

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

### **Equality and Diversity**

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

### Submitting your application

Once you've filled out and completed everything, you'll be prompted to submit your application. Simply click the button and you're done. If, at any stage, you have questions or problems, please contact the recruitment team on 0845 602 6099 or email <u>ea recruitment@sscl.gse.gov.uk</u>
