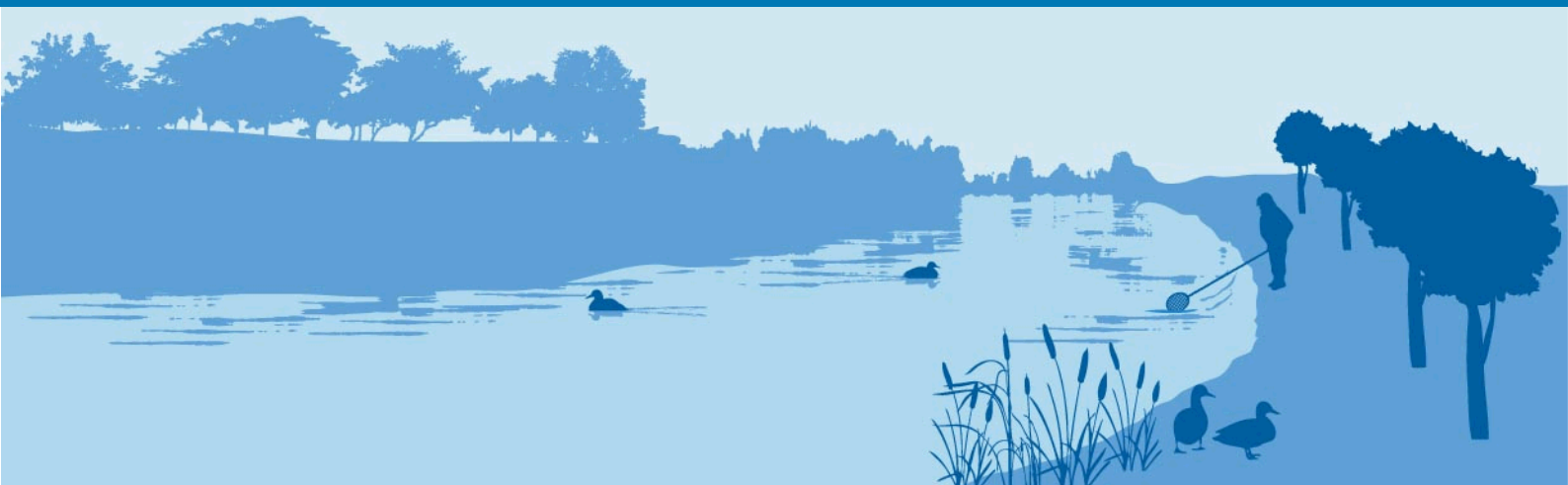

2. The role

Role

Contribute to the effective management, regulation and development of navigation and recreation activities on and around Environment Agency Waterways through routine river patrols.

Principal accountabilities

1. Through regular river patrols report, and where possible deal with issues which affect the Waterways, using local knowledge and experience to enhance the use and enjoyment of the Waterways by the public for all forms of recreation.
2. Carry out navigation enforcement and regulation to meet statutory and Environment Agency requirements and to ensure the safe and effective use of the navigation.
3. Carry out effective, efficient and timely responses to emergency incidents to meet statutory and Environment Agency requirements.
4. Promote the health and safety of all staff and visitors on the site by reporting or addressing identified hazards and adhering to safe practices.
5. Provide efficient and friendly service and advice to customers and look for opportunities to improve and develop services and products, both to increase customer satisfaction and to increase income generated
6. Take part in cross-team projects and working groups to allow solutions to be developed which either give maximum enhancement or minimal detriment to the environment.
7. In consultation with Team Leaders, receive, appraise, comment on and negotiate in relation to developments and proposed authorisations to ensure protection and enhancement of navigation and recreation interests and compliance with legislation.

Knowledge/Qualifications

1. Minimum advanced academic level required (A level or equivalent experience).
2. A practical knowledge of boating is required for this role. Qualifications such as RYA Powerboat 2 may be an advantage but not essential as included in the training for this role.
3. An understanding of Health & Safety at public sites.
4. An understanding of tourism and marketing.

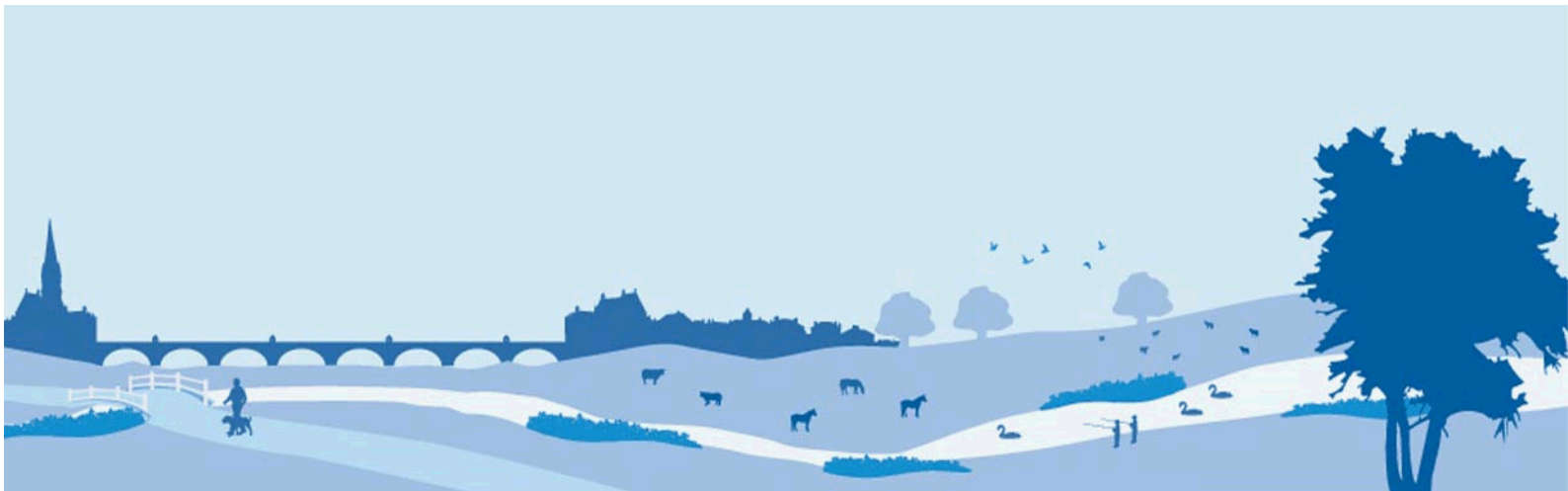
Skills/Abilities/Experience

1. Strong interest and/or experience of Waterways and boating.
2. Previous experience of an enforcement role.
3. Highly developed interpersonal skills and good communication skills.
4. Well developed organisational skills and the ability to prioritise workloads appropriately.

| Leave entitlement: | <p>Your leave allowance in this role will be 25 days plus bank holidays (pro-rata - if part time or an assignment).</p> <p>We also offer up to two days paid environmental outcome days each year. These give you the opportunity to take part in community activities with a clear environmental outcome for people and wildlife.</p> |
| Pension: | <p>We will enrol you into the Environment Agency Pension Fund (EAPF) on commencing employment, if your employment contract is for 3 months or more. The EAPF is part of the Local Government Pension Scheme (LGPS). It is a career average scheme, which means you will build up benefits based on your pay each scheme year rather than your final salary.</p> <p>We will base your pension contributions on your actual pay and you will receive tax and national insurance relief on your contributions. The pension contribution rates currently range between 5.5% to 12.5%. Whilst you are in the scheme we will also pay an employer contribution into your pension pot. We currently pay 17.5%, so this is a very generous scheme.</p> |
| Work/life balance: | We support flexible working hours and practices to help you strike a good balance between your work life and your personal life. We will also encourage you to keep developing your skills and professional knowledge throughout your career. |

Please note that Environment Agency employees are not civil servants so you may wish to check your eligibility for continuity of employment by contacting your HR department. All eligible bodies are listed in the Redundancy Payments (Continuity of Employment in Local Government etc.) (Modification) Order 1999.

Employment agency workers and contractors are considered to be external candidates and should therefore only apply for positions that are being advertised externally. They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

Please note all successful applicants must undergo Baseline Personnel Security Standard (BPSS) checks prior to commencement of employment. This includes a basic criminal records check.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.

5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting '**Apply**' at the bottom of the advert. (For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.) Once you've clicked this link you'll then be asked 'Do you have the right to live and work in the UK?', 'Do you have the required qualifications or equivalent experience, which were stated in the job advert?' and 'Are you currently an employee of this organisation?' Simply answer yes or no and you can carry on with your application. You'll then see the '**Register**' page. Simply complete the details and select '**Submit Registration**' and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 20 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

Competence Questions/Statement

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us! You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250 character limit per competence including spaces (750 for an overall statement). It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.

Application questions

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

Equality and Diversity

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

Submitting your application
