## 2. The role

### Role

Carrying out a range of Environment, Planning & Engagement (EPE) and supporting incident management activities within the area as a whole in order to deliver EPE outcomes.

### Principal accountabilities

- Plan and co-ordinate work with area teams to provide relevant, scientifically sound, integrated, accurate and timely advice on development proposals to local authority planners and developers, so that our advice is highly influential and delivers planning decisions which deliver our environmental objectives.
- Co-ordinate our participation on less complex, lower risk statutory planning appeals. Manage a multifunctional team of experts to ensure integrated, relevant, timely and scientifically sound Environment Agency participation.
- Develop and maintain a strong customer focus to ensure effective relationship building and partnership working to achieve environmental goals. This will generally include Local Planning Authority case officers, developers and consultees from other teams to help influence and support environmental outcomes.
- Co-ordinate and chase responses to correspondence and enquiries, ensuring that internal and external information is effectively processed and tracked to ensure compliance with Environment Agency policy and procedure.
- Maintain and develop information storage and retrieval systems and ensure that information is up to date and readily accessible to facilitate departmental workflow.
- Participate in the development of team work plans and undertake any agreed actions effectively, to contribute to business planning and delivery.
- Support health & safety best practice by actively promoting awareness and ensuring the provision of safe working practices to comply with Environment Agency policies and standards.

### Knowledge/Qualifications

- Educated to degree or equivalent level in a relevant discipline. Workplace experience might be considered in place of formal education qualifications.
- For some roles, a desire to work towards a specific professional qualification or membership of a professional body.

## **Skills/Abilities/Experience**

- Delivering work by planning, tracking, gathering, maintaining, quality-assuring and analysing data/information.
- Ability to develop and maintain good relations with customers and adapt behaviour to different situations and people.
- Contribute to the delivery of low to medium risk multi-disciplinary projects and/or activities to time, cost and quality, ensuring successful outcomes are achieved.
- Being open to change and new ways of working.
- Working under own initiative and as part of a team to make decisions and achieve planned outcomes.
- Using good written and spoken communication skills to convey information to colleagues and customers.
- Basic understanding of the planning system and relevant legislation.

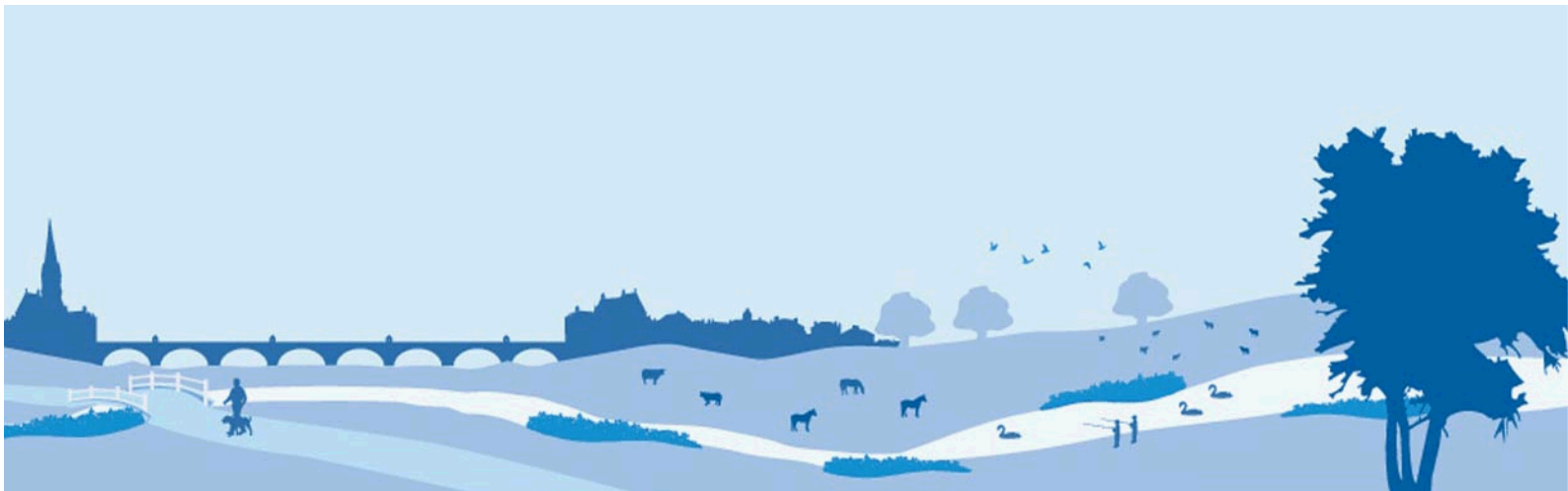
The role with EPE may be required to take part in incident response. The line manager will confirm the specific arrangements depending on the role.

### 3. Salary and benefits

Join us in this role and you will enjoy the following benefits:

<b>Grade Rate:</b>	£22,211
<b>Location:</b>	Nene House & Kettering Depot, Pytchley Ln, Kettering NN15 6JQ Waterside House, Lincoln, LN2 5HA
<b>Hours of work:</b>	37 hours FTE, Permanent contract
<b>Leave entitlement:</b>	Your leave allowance in this role will be 25 days plus bank holidays  We also offer up to two days paid environmental outcome days each year. These give you the opportunity to take part in community activities with a clear environmental outcome for people and wildlife.
<b>Pension:</b>	<p>We will enrol you into the Environment Agency Pension Fund (EAPF) on commencing employment, if your employment contract is for 3 months or more. The EAPF is part of the Local Government Pension Scheme (LGPS). It is a career average scheme, which means you will build up benefits based on your pay each scheme year rather than your final salary.</p> <p>We will base your pension contributions on your actual pay and you will receive tax and national insurance relief on your contributions. The pension contribution rates currently range between 5.5% to 12.5%. Whilst you are in the scheme we will also pay an employer contribution into your pension pot. We currently pay 17.5%, so this is a very generous scheme.</p>
<b>Work/life balance:</b>	We support flexible working hours and practices to help you strike a good balance between your work life and your personal life. We will also encourage you to keep developing your skills and professional knowledge throughout your career.
<b>Diversity:</b>	We are committed to diversity and inclusion. We want all our staff to feel valued and respected and to see this as a great place to work. Diversity: it's in our nature.
<b>Relocation:</b>	If you need to relocate to take up this role, we might be able to offer financial help with this. This will depend on your circumstances, so if it's something you are interested in, please discuss it with us to find out what the options are.

Please note that Environment Agency employees are not civil servants so you may wish to check your eligibility for continuity of employment by contacting your HR department. All eligible bodies are listed in the Redundancy Payments (Continuity of Employment in Local Government etc) (Modification) Order 1999.

Employment agency workers and contractors are considered to be external candidates and should therefore only apply for positions that are being advertised externally. They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

Please note all successful applicants must undergo Baseline Personnel Security Standard (BPSS) checks prior to commencement of employment. This includes a basic criminal records check.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.

## 5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting '**Apply**' at the bottom of the advert. (For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.) Once you've clicked this link you'll then be asked 'Do you have the right to live and work in the UK?', 'Do you have the required qualifications or equivalent experience, which were stated in the job advert?' and 'Are you currently an employee of this organisation?' Simply answer yes or no and you can carry on with your application. You'll then see the '**Register**' page. Simply complete the details and select '**Submit Registration**' and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 20 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

### Competence Questions/Statement

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us! You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250 character limit per competence including spaces (750 for an overall statement). It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.



## Application questions

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

## Submitting your application

Once you've filled out and completed everything, you'll be prompted to submit your application. Simply click the button and you're done.
