2. The role

Role

Contribute to the management, regulation and development of navigation and recreation activities on and around all lock sites on the waterway and in the reaches associated with those locks, providing safe passage and enjoyment for boaters. Provide training to and mentor colleagues. Assist other Waterway Officers, Team Leaders and Managers with their work by providing localised expertise and knowledge to ensure the most effective management of the navigation.

Principal accountabilities

Provide accurate and timely support for operational decisions and environmental issues by carrying out analysis and interpretation of data and preparing reports from information and field investigations.

- 2. Contribute to investigations, identifying concerns and providing a first level technical response to the team and other functions, in line with Environment Agency policy, to help influence and support environmental outcomes.
- 3. Check compliance with environmental standards and service levels and undertake front line investigation e.g. inspection, monitoring, survey work, in order to carry out and support the business plan and environmental outcomes.
- 4. Interpret and implement basic scientific and technical procedures and principles in an integrated manner to assist in resolving problems.
- 5. Co-ordinate and chase responses to correspondence and enquiries, ensuring that internal and external information is effectively processed and tracked to ensure compliance with Environment Agency policy and procedure.
- 6. Develop and maintain a strong customer focus to ensure effective relationship building and partnership working to achieve environmental goals.
- 7. Maintain and develop information storage and retrieval systems and ensure that information is up to date and readily accessible to facilitate departmental workflow.

- 8. Participate in the development of team work plans and undertake any agreed actions effectively, to contribute to business planning and delivery.
- 9. Support health & safety best practice by actively promoting awareness and ensuring the provision of safe working practices to comply with Environment Agency policies and standards.

Knowledge/Qualifications

Numeracy and literacy.

Practical and technical skills and knowledge developed through appropriate vocational training and / or apprenticeship

Skills/Abilities/Experience

Relevant experience in waterway or similar customer-focussed work with a significant safety and regulatory role in order to ensure capability from the commencement of employment in;

Operating, or overseeing the operation of, locks efficiently to provide safe passage for boats

Monitoring water levels and managing and regulating the weir structure at all sites in the area to maintain appropriate levels whenever possible.

Patrolling the waterway to monitor the condition of the waterway, delivering stores and equipment, providing customer contact and assisting in enforcement.

Procuring and maintaining of supplies and equipment e.g. for locksites, boats and boatsheds.

Assisting in the supervision and training of assistants, colleagues and new recruits and act as mentor to employees in order to support the development of knowledge and skills for the competent performance of their roles, by promoting best practice and giving advice to promote a strong and consistent knowledge base.

Enforcing regulations e.g. to ensure lawful use of the navigation.

Administering revenue collection and accounting for payments received to comply with financial regulations

Promoting public and staff safety. Reporting hazards, near misses and accidents and adhering to safe practices to minimise the risk of accident.

Liaising with stakeholders and customers and promoting recreational activity and use

Such other duties commensurate with the role that may from time to time be prescribed by management

Participation in standby rota to provide out of hours emergency response to incidents on or near the waterway to make sure adequate emergency cover is available outside normal working hours. Preparedness to respond to call-outs when not on standby

Familiarity with all aspects of lock and weir keeping and day-to-day site management Have or be in a position to achieve appropriate boat handling qualifications Self motivated and able to work well as part of a team as well as independently

3. Salary and benefits

Leave entitlement: Your leave allowance in this role will be 25 days plus bank holidays

We also offer up to two days paid environmental outcome days each year. These give you the opportunity to take part in community activities with a clear environmental outcome for people and wildlife.

Pension: We will enrol you into the Environment Agency Pension Fund (EAPF)

on commencing employment, if your employment contract is for 3 months or more. The EAPF is part of the Local Government Pension Scheme (LGPS). It is a career average scheme, which means you will build up benefits based on your pay each scheme year rather

than your final salary.

We will base your pension contributions on your actual pay and you will receive tax and national insurance relief on your contributions. The pension contribution rates currently range between 5.5% to 12.5%. Whilst you are in the scheme we will also pay an employer contribution into your pension pot. We currently pay

18.5%, so this is a very generous scheme.

Work/life balance: We support flexible working hours and practices to help you strike a

good balance between your work life and your personal life. We will

also encourage you to keep developing your skills and professional knowledge throughout your career.

The Environment Agency values a diverse workforce and welcomes applications from all sections of the community who wish to join a workforce which embraces difference and welcomes everyone.

Please note that Environment Agency employees are not civil servants so you may wish to check your eligibility for continuity of employment by contacting your HR department. All eligible bodies are listed in the Redundancy Payments (Continuity of Employment in Local Government etc) (Modification) Order 1999.

Employment agency workers and contractors are considered to be external candidates and should therefore only apply for positions that are being advertised externally. They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

Please note all successful applicants must undergo Baseline Personnel Security Standard (BPSS) checks prior to commencement of employment. This includes a basic criminal records check.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.

5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting 'Apply' at the bottom of the advert. (For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.) Once you've clicked this link you'll then be asked 'Do you have the right to live and work in the UK?', 'Do you have the required qualifications or equivalent experience, which were stated in the job advert?' and 'Are you currently an employee of this organisation?' Simply answer yes or no and you can carry on with your application. You'll then see the 'Register' page. Simply complete the details and select 'Submit Registration' and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 60 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

Competence Questions/Statement

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us! You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250 word limit per competence including spaces. It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.

Application questions

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

Equality and Diversity

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

Submitting your application
