# 2. Salary and benefits

Join us in this role and you will enjoy the following benefits:

**Grade Rate:** £46,374 (pro-rata - if part time)

Location: Birmingham, Worthing, Warrington, Reading

Hours of work: 37 hours FTE, Permanent

Leave entitlement: Your leave allowance in this role will be 27 days or equivalent,

> depending on working pattern, plus bank holidays. Your allowance will be pro-rata if you work part time or you are on an assignment to a role at a higher grade that attracts an increased entitlement. Your entitlement depends on your grade, your contracted hours, and your

length of continuous service.

We also offer up to two days paid environmental outcome days each year. These give you the opportunity to take part in community activities with a clear environmental outcome for people and wildlife.

**Pension:** We will enrol you into the Environment Agency Pension Fund (EAPF)

on commencing employment, if your employment contract is for 3 months or more. The EAPF is part of the Local Government Pension Scheme (LGPS). It is a career average scheme, which means you will build up benefits based on your pay each scheme year rather

than your final salary.

We will base your pension contributions on your actual pay and you will receive tax and national insurance relief on your contributions. The pension contribution rates currently range between 5.5% to 12.5%. Whilst you are in the scheme we will also pay an employer contribution into your pension pot. We currently pay 19%, so this is a

very generous scheme.

#### Work/life balance:

We support flexible working hours and practices to help you strike a good balance between your work life and your personal life. We will also encourage you to keep developing your skills and professional knowledge throughout your career.

As government restrictions continue to lift, Defra group is exploring future ways of working with flexibility in mind. This means, that subject to business need, successful candidates will be offered the option to combine working at home with working at their contractual Defra group workplace, with occasional travel to other work locations. Further information relevant to this post will be available for candidates invited to interview.

#### **Diversity:**

We are committed to diversity and inclusion. We aspire to be the best employer in the country for equality, diversity and inclusion (EDI) and want all our staff to feel valued and respected and to see this as a great place to work. #### **Tenancy deposit loan:**

Our Tenancy Deposit Loan scheme assists employees directly employed by the Environment Agency in meeting the costs of a deposit for a privately rented home, which can sometimes act as a barrier to moving.

The scheme gives access to an interest free loan to pay for some or all of a deposit on a privately rented home. The loan can be paid back over a period of up to 12 months, directly from the monthly salary.



### 3. The role

Our advert describes the day-to-day activities of the role, the team it operates within and the skills/experience we're looking for from applicants. This information should be read in conjunction with the job family role profile that we've provided.

In the Environment Agency, our roles are grouped by grade and similar characteristics into one of seven job families. Job families describe the work undertaken in broad terms. This enables us to use generic profiles to broadly describe 80% of the key accountabilities, skills and experience for each job family at each grade.

The role of NEAS Principal Environmental Project Manager fits into our Asset Management job family at Grade 6.

#### **Additional information**

NEAS ensure that Environmental Impact Assessment (EIA) of all the Environment Agency's capital projects and the Strategic Environmental Assessment (SEA) of the Agency's relevant Strategies and Plans are conducted, such that projects are built in full compliance with environmental legislation and policy. The service also provides additional guidance and advice on landscape and archaeological issues. NEAS has a remit to look at, or screen, all work programmes to identify the level of environmental assessment needed. We do this to ensure our projects are legally compliant and that we apply Environment Agency policy on EIA and SEA effectively.

In our duties and services we seek to ensure that our capital and operational strategies and projects are implemented without undue adverse effect or hold ups caused by unresolved environmental issues. We seek to ensure that all options to avoid or reduce impacts and enhance the environment are investigated, and where agreed, implemented.

The Principal Environmental Project Manager (PEPM) is a key role, providing technical leadership on major projects within the Hub. Depending on which Hub you are appointed to, you will lead on....

Midlands Hub (Birmingham) role – Upper Severn and East Lincolnshire Coast projects South East Hub (Worthing) role – North Kent, Sussex and Hampshire Coastal projects North West Hub (Warrington) – Greater Manchester, Lancashire and Cumbria projects Eastern Hub (Reading) role – Thames Valley (Oxfordshire) projects

You will be responsible for the technical oversight of environmental risk and opportunities associated with the major project, including environmental governance, steer and the workstream lead for Environment and Sustainability in these two locations. You will work together with colleagues and Supply Partners to drive sustainable delivery of major projects on the capital programme and ensure we have a sustainable pipeline of work moving forwards.

You will work closely with a variety of other roles, partners and people to ensure this Environment and Sustainability work is integrated into the wider programme and project activities. You will ensure that relevant people are always up to speed with any ongoing issues and opportunities and will support the wider Hub translate strategic policies into reality on the ground. You will manage relationships with partners (such as Natural England), ensuring that the casework load is appropriately planned and managed, as well as ensuring high quality of service.

You will also ensure technical environmental input and assurance to some of the wider programme within the Hub, engaging with statutory environmental stakeholders as appropriate. Working at a programme level, you will maintain an overview of environmental risk and opportunity, ensuring that the programme is legally compliant from an environmental perspective and champion the identification and delivery of environmental improvements for people and wildlife.

With Sustainability being central to future flood risk management work, you will support the preparation of the Sustainability Plan for the Hub alongside the Supply Partner Sustainability Leads and champion its delivery. You will also contribute to the collaborative Hub Sustainability Group which comprises EA staff and Supply Partners. You will engage with the Integrated Delivery Team as required to influence decisions relating to environment and sustainability.

You will oversee the technical environmental skills across the Hub team (through coordination and delivery of training, providing technical mentoring to staff to ensure people have the necessary capabilities), support key project related decisions, and ensure that strategic and Hub priorities are taken into account in programme and project level decisions.

You will be part of the NEAS leadership team for the Hub, alongside the Operational Unit Manager, Team Leader and Hub PEPM. Together they look after the team, represent them at senior management level and manage the resources so the Hub team has the right people working on the right things at the right time. You will support the technical leadership of NEAS, working with the community of other Principals to share learning across England and support each other to ensure NEAS has the skills and guidance it needs. You may also have the opportunity to lead and/or contribute to national pieces of work to help NEAS work more effectively as a team, with other parts of the Environment Agency and with delivery partners.



### 4. Further Information

The Environment Agency values a diverse workforce and welcomes applications from all sections of the community who wish to join a workforce which embraces difference and welcomes everyone.

We aim to create and maintain a diverse workforce (including our Board and Executives) that better reflects the UK's economically active population. Therefore, we particularly welcome applications from Black, Asian and Minority Ethnic (BAME), disabled, female and LGBT+ candidates who are under-represented across our workforce.

We will consider flexible working patterns for all our vacancies, including job share, so please include clearly any information regarding your preferred working arrangements on your application.

Moving forward (and Covid19 permitting), the role will require regular travel to project sites and project team meetings in other Agency and Supply Partner offices. Occasionally, overnight stays will be necessary.

#### Eligibility to apply and continuity of employment

Employment agency workers and contractors are considered to be external candidates and should therefore only apply for positions that are being advertised externally. They are also not eligible to claim continuity of employment should they be successful in securing a position with the Environment Agency.

If you have been a member of a Regional Flood and Coastal Committee in the last 12 months we will not be able to continue with your application based on agreed appointment rules related to employing ex-RFCC members. We would welcome an application from you once the 12-month period have passed.

For applicants who currently work in local government or other bodies listed in the Redundancy Payments (Continuity of Employment in Local Government etc.) (Modification) Order 1999, you may be eligible for continuous service for the purpose of calculating any future redundancy payment. In addition, if you can demonstrate that you have worked at the Environment Agency immediately before joining the Civil Service and are now being re-employed by the Environment Agency within a period of three years of leaving, you may also count your Civil Service employment for the purpose of calculating your service-related entitlements as outlined above. If you are unsure of your status then you should contact your own HR Team.



### 4. Further Information

#### **Pre-employment Checks**

We apply the Baseline Personnel Security Standard (BPSS) check when recruiting staff to our posts. This includes a basic criminal records check.

For the great majority of roles in the Environment Agency this will be sufficient and only certain roles will require a higher level of clearance. Should this be necessary, you will be advised of this during the recruitment process.

Positions based at our London office or roles that require frequent travel to London require CTC level security clearance. This will be confirmed to you during the recruitment process.

### 5. How to apply

We use an online recruitment system. To make the application process simple and straightforward, and so that you know how it works and what we need from you, we've put together a few hints and tips. Make sure you have all the information you need about the vacancy. For some jobs, you'll be asked to download a candidate pack, like this one, where you'll find specific application instructions.

The first thing you need to do is sign up to our recruitment system. You will need a valid e-mail address to log in and apply for opportunities, as all communication from us will be via e-mail. You can do this via the vacancy you are interested in by selecting 'Apply' at the bottom of the advert.

Once you've clicked this link you'll then be asked:

- Do you have the right to live and work in the UK?
- Do you have the required qualifications or equivalent experience, which were stated in the job advert?
- Are you currently an employee of this organisation?

Simply answer yes or no and you can carry on with your application. You'll then see the 'Register' page. Simply complete the details and select 'Submit Registration' and register to the system. You only need to sign up to the system once; you'll just be able to login next time.

When it comes to the actual application, you need to fill out each section, please be aware that the system will automatically time out if you are inactive for more than 60 minutes. This will result in any unsaved information being lost so make sure you save what you are doing regularly. Once you've finished, your details and information will be saved on the system for any future applications – of course, you can edit your details at any point.



# 5. How to apply continued

When you apply to the Environment Agency for a job we will ask you to provide your personal data on our application form. We need this information so that we can establish your identity and your right to work in the UK.

You can read our Data Protection Statement on the application process page of our recruitment system. It is also available for reference on each page of the actual application.

#### **Competence Questions/Statement**

We're keen to know what makes you right for the job you're applying for and why we should ask you in for an interview. The competence questions/statements are your chance to convince us!

You should demonstrate how your skills, qualities and experience meet the requirements of the job (as described in the job advert and candidate pack). And instead of simply telling us, show us: use real life examples of where you've used a certain skill or how you've practically applied your experience.

There's a 250-word limit per competence including spaces. It's a really important part of the selection process so make sure you keep your statement relevant and concise. Think about what we need to know about you and what you'd bring to the role and our organisation.

#### **Application questions**

For some roles, we'll ask you some specific questions, like if you have a preferred work location. If you're disabled and you'd like to be part of our Guaranteed Interview Scheme, you can add this information in here.

#### **Equality and Diversity**

We're committed to reflecting the communities we serve and we'd like you to tell us about yourself and your background.

#### Submitting your application

Once you've filled out and completed everything, you'll be prompted to submit your application. Simply click the button and you're done.

Please be aware that once you've submitted your application, with the exception of the 'Personal Details' section you will not be able to edit your application further. If you decide to withdraw your application, you will not be able to submit another application for the same vacancy.
